Due to rejection of license from the federation Club Licensing First Instance Body (FIB), the Member Association and respective Club above highlighted in red **SHOULD NOT** be allowed to take participate in the WCL Egypt 2021 season, namely:

- **MOZAMBIQUE (Costa de Sol FC)**
 - The club licensing First Instance Body (FIB) of the MA, having analysed the documents of the candidate club for participation in the CAF Women Champions League Egypt 2021 has decided to reject the license to the club for non-fulfilment of the criteria for this competition.

Due to non-submission of licensing decisions nor a request for extension, the Member Association and respective Club above highlighted in red **SHOULD NOT** be allowed to take participate in the WCL Egypt 2021 season, namely:

- **ERITREA (Denden Football Club)**
 - On the 21 June, after the set deadline date for communication of club licensing decisions for the WCL Egypt 2021 (18 June), a reminder was sent to the concerned MA, however no response.
 - Licensing decision not communicated by the MA to CAF (Club not Licensed to participate in WCL).
- **SUDAN (Aldeefa Khartoum)**
 - On the 21 June, after the set deadline date for communication of club licensing decisions for the WCL Egypt 2021 (18 June), a reminder was sent to the concerned MA, however no response
 - Licensing decision not communicated by the MA to CAF (Club not Licensed to participate in WCL)

I. Summary of the Club Licensing Process for the CAF Women's Champions League Egypt 2021

According to the CAF Women's Champions League Egypt 2021 regulations, all engaged clubs must undergo a licensing process at the Member Association level and have been granted a license to participate in the aforementioned competition.

The deadline date of **18 June 2021** was set by CAF for receiving the licensing decisions for the clubs affiliated to the Member Associations which intend to participate in the CAF Women's Champions League Egypt 2021

For club licensing communication procedure, the Member Associations were requested to send to the CAF Club Licensing Department (club.licensing@cafonline.com) while copying the respective Member Association CAF zone the following documents:

- 1. Licensing decisions + Minutes of the meetings of the decision-making bodies signed by the Chairman and all the members, examining compliance of each criterion by which licenses were granted to a Club;**
- 2. Filled Federation Report and Club Report;**
- 3. A copy of the Clubs Head Coach coaching license.**

The CAF Member Associations were duly informed that only the engagement of a club on to the competitions management system of CAF (CMS) and/or engagement through the zone is not sufficient and it must be accompanied by the licensing procedure of the club at the federation.

Moreover, the Member Associations were also informed via circular and workshops that in the case the federation failed to provide the above-mentioned documents, their clubs engagement and participation could be rejected for the CAF Women's Champions League Egypt 2021 (zonal qualifiers and final phase).

The CAF Women's Champions League Egypt 2021 Club licensing requirements were set in the *CAF circular dated - 2 June 2021* and duly communicated to all the CAF Member Associations and zones. As a pilot competition, CAF has decided to make mandatory selected minimum Club Licensing requirements, such as:

Article 25 Medical Care of Players
INFRASTRUCTURE CRITERIA
Article 28 Availability of Training facilities
ADMINISTRATIVE AND PERSONNEL CRITERIA
Article 31 General Manager/CEO or Individual(s) Responsible for the Management of Women's Football
Article 32 Medical doctor
Article 33 Physiotherapist
Article 34 Head Coach of first squad
Article 35 Assistant Coach of first squad
Article 36 Officers and/or Coaching staff in the Team Delegation
LEGAL CRITERIA
Article 43 Declaration in Respect of Participation in CAF Women's Champions League
Article 44 Minimum Legal Documents
FINANCIAL CRITERIA
Article 48 Bank Account

In terms of the Coaching License requirements for the CAF Women's Champions League Egypt 2021 (zonal qualifiers and final phases), the following coaching requirements were set as mandatory:

Head Coach Licence:

- **CAF "A", "B" or "C"**
- **Other Confederation "PRO", "A", "B"**

Assistant Coach Licence:

- **No requirement this season**
