



Club Licensing Catalogue of Sanctions

Edition 2022

Part I - General Provisions

- 1. The implementation of the Club Licensing Procedure must be respected by all CAF Member Associations. The CAF Club Licensing Regulations stipulates that CAF shall implement a catalogue of sanctions and carry out spot-checks with the Licensors (Member Associations or Leagues) to ensure that the licenses are properly awarded.
- 2. In order to guarantee an appropriate assessment process, CAF shall, amongst other things:
- a. Set up a schedule of sanctions applicable for the club licensing system, which pertains to determine necessary sanctions against the necessary Member Associations/licence applicants/ licensees.

Part II – Jurisdiction of the CAF Disciplinary Board

- 1. The CAF Disciplinary Board is competent to:
 - a. determine whether licensors have fulfilled their obligations and whether licence applicants have fulfilled the licensing criteria as defined in the CAF Club Licensing regulations at the time the licence was granted;
 - b. determine whether, after the licence has been granted, licensees continue to fulfil the licensing criteria as defined in the CAF Club Licensing regulations;
 - c. impose disciplinary measures as defined in these rules in the event of non-fulfillment of the requirements set out in the CAF Club Licensing regulations.

Part III - Role of the CAF Administration

- 1. The CAF administration assists the CAF Disciplinary Board in the fulfilment of its tasks as set out in these catalogues of sanctions.
- 2. The CAF administration provides the CAF Disciplinary Board with the staff, infrastructure, and administrative support at CAF headquarters necessary to accomplish its tasks.
- 3. It is the responsibility of the CAF administration to conduct all preliminary analysis related to the fulfilment of the obligation of the Licensors and the License applicants, and subsequently reporting infractions to the CAF Disciplinary Board.

NOTES:

Fines are doubled in case of repetition.

CAF keeps the right to impose more sanctions rather than the ones mentioned in this frame if necessary, at all times.

CAF to decide on other cases not mentioned here as they appear.

In case of multiple violations, a maximum global fine amount is to be considered per section, as indicated below:

Part V – Others Disciplinary measures

- The CAF Disciplinary Board is competent to determine whether clubs have fulfilled (and continue to comply with) the licensing criteria as set out in the CAF Club Licensing Regulations, including in respect of overdue payables. Along with the sanctions set in part IV of these catalogue of sanctions, the following disciplinary measures may be imposed against a club for non-compliance:
 - · Warning;
 - · Reprimand;
 - Fine;
 - · Deduction of points;
 - · Withholding of revenues from a CAF competition;
 - · Prohibition on registering new players in CAF competitions;
 - Restriction on the number of players that a club may register for participation in CAF competitions, including a financial limit on the overall aggregate cost of the employee benefits expenses of players registered on the A-list for the purposes of CAF club competitions;
 - Disqualification from competitions in progress and/or exclusion from future competitions;
 - · Withdrawal of a title or award.





2. These sanctions may be combined. There is therefore a strong incentive for clubs to comply with the CAF Club Licensing regulations regarding.

Part VI – Final Provisions

- 1. The application of these CAF Club Licensing catalogue of sanctions shall be done by the CAF Disciplinary Board in accordance with the CAF Club Licensing System regulations and relevant Disciplinary Codes.
- 2. All Disciplinary aspects will be dealt by the CAF Disciplinary Board.
- 3. The CAF Club Licensing catalogue of sanctions is available in English, French and Portuguese. In the event of discrepancy between the three linguistic versions, the French version shall be authoritative.
- 4. The CAF Club Licensing catalogue of sanctions were adopted by the Executive Committee on 10 December 2020 and come into force on 1 July 2022.
